The school undertake to abide by the provisions contained in the affiliation & examination byelaws directions issued time to time and the law of the land.

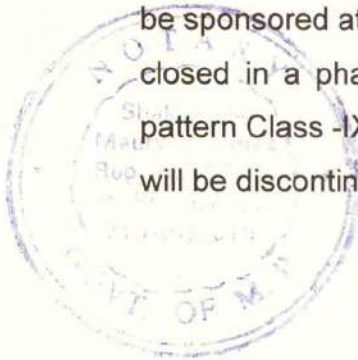
